WHEREAS, the Commissioner of Public Works has been notified by the New York State Department of Transportation of an allotment in Emergency Winter Recovery (EWR) funding for Ulster County Highway Capital Improvements in the amount as the previous year for the State fiscal year 2025-2026; and

WHEREAS, the Commissioner of Public Works has been notified by the New York State Department of Transportation of a decrease in Pave our Potholes (POP) funding for Ulster County Highway Capital Improvements in the amount of \$3,337.00 for the State fiscal year 2025-2026; and

WHEREAS, there exists a 2024 CHIPS budget balance of \$662,790.00 to be rolled over into the 2025 Budget; and
