WHEREAS, this resolution has been submitted at the request of the County Executive on behalf of the Ulster County Department of Mental Health; and

WHEREAS, the Ulster County Department of Mental Health has received notification from the New York State Office of Addiction Services and Supports (OASAS) of one-time funding to support electric repairs for the Residential Services – Reintegration Program as per OASAS State Aid Funding Authorization dated June 14, 2022; and

WHEREAS, in order to reflect the increased funding, an amendment of the 2022 budget is necessary; and

WHEREAS, there is no increase in County Contribution as a result of these modifications; now, therefore be it

RESOLVED, that the Ulster County Legislature hereby approves the contract amendment with New York State Office of Addiction Services and Supports (OASAS) for funding to support electric repairs for the Residential Services – Reintegration Program as per OASAS State Aid Funding Authorization dated June 14, 2022 ; and, be it further
