Chairman Kenneth J. Ronk, Jr. offers the following:

WHEREAS, the Clerk of the Ulster County Legislature is appointed by the Legislative body; and

WHEREAS, there is tremendous value in maintaining a staff with institutional knowledge whose members are appointed on the basis of qualifications and not politics; and

WHEREAS, it is the desire of the Ulster County Legislature to amend Rule 11 of the Rules of Order of the Ulster County Legislature to maintain the most professional office possible to equally serve all members of the Legislative body as well as the public; now, therefore be it

RESOLVED, that Rule 11. Clerk of the Legislature; Duties. A. is hereby amended to read as follows:

## RULE 11. CLERK OF THE LEGISLATURE; DUTIES.

A. During the first organizational meeting for each new County Legislature, a Clerk of the County Legislature shall be appointed by resolution by the County Legislature and such appointed Clerk shall serve for the duration of the appointing Legislature's term. In the event of vacancy, the Legislature shall appoint by resolution a new Clerk of the Legislature. The removal of the Clerk shall only be done by resolution with a favorable vote of at least three-fifths of the whole number of the Legislature. Deputy Clerks and employees of the Legislature shall be appointed in accordance with the Rules of Order of the Legislature. [Amended pursuant to Local Law No. 1 of 2017.] The Chairperson may appoint such Deputy Clerks and employees as the Legislature may require.

**1.** The Clerk of the Legislature may appoint such Deputy Clerks and employees as the Legislature may require.

2. The Chairperson may appoint a confidential secretary to the Chairperson to report directly to and serve at the pleasure of the Chairperson.
