WHEREAS, a contract for execution by the County with The Hudson Valley Agri-Business Development Corporation has been submitted for approval by the Ulster County Legislature, which is described below:

2024-387 - American Rescue Plan Act funding for: develop and administer a grant program as a Subrecipient under the ARPA-SLFRF to benefit the economic viability and sustainability of Ulster County farms which shall be titled – The Ulster County Farm Viability and Sustainability Grant. 2.
