

Amending The 2013-2018 Capital Program For Capital Project No. 389 And Appropriating Funds For Replacement Of The Hurley Bridge (County Bridge #74) – Department of Public Works (Highways & Bridges)

Chairman of the Public Works and Capital Projects Committee, Dean J. Fabiano, and Deputy Chairman John Parete offer the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Public Works; and

WHEREAS, the Ulster County Legislature adopted the Capital Program for the Years 2013-2018 which included the Hurley Bridge (County Bridge #74) project at a cost of \$200,000.00; and

WHEREAS, the Ulster County Legislature established Capital Project No. 389 for the rehabilitation of the Hurley Bridge (County Bridge #74) by Resolution No. 104 dated April 16, 2013; and

WHEREAS, the New York State Department of Transportation inspects bridges on an annual basis and a recent inspection has determined that the Hurley Bridge (County Bridge #74) superstructure has shown a steady rate of deterioration to the point where imminent failure of critical components is possible; and

WHEREAS, due to severe deterioration, the weight limit on the bridge has been significantly reduced causing difficulties in the daily lives of the community and traveling public; and

WHEREAS, the Hurley Bridge (County Bridge #74) now needs superstructure demolition and replacement, which was not contemplated in the original estimate for repair and has led to additional estimated costs in the amount of \$929,000.00; and

WHEREAS, the Ulster County Department of Public Works intends to contract with an outside bridge contractor for demolition and removal of the existing truss of the Hurley Bridge (County Bridge #74) with installation of a new truss, deck and pavement to be done in-house; and

WHEREAS, the Commissioner of Public Works now requests funds for the replacement of the Hurley Bridge (County Bridge #74) on Wynkoop Lane, over the Esopus Creek in the Town of Hurley (BIN #3346880); now, therefore, be it

RESOLVED, that Capital Project No. 389 contained within the 2013-2018 Capital Program, is hereby increased by \$929,000.00 and made available to cover the cost of the Project, thereby increasing the total Project cost to \$1,129,000.00; and, be it further
