WHEREAS, Ulster County has demonstrated its environmental commitment and leadership by achieving Certified Silver status in the New York State Climate Smart Communities Program (CSC) Program and being designated a NYSERDA Clean Energy Community (CEC); and

WHEREAS, the fourteenth round of the CFA is now open, with an application deadline of July 31st at 4:00pm; and

WHEREAS, the New York State Energy Research and Development Authority (NYSERDA) Building Cleaner Communities Competition has incentives available to support regionally significant, carbon neutral and resilient projects in New York State; and

WHEREAS, the Department has determined that an appropriate grant application includes the use of funding to provide geothermal installation at the County's Community Wellness Hub located at 368 Broadway in the City of Kingston; and

WHEREAS, the state share will be a maximum of 60% of the total project costs or Two Million (\$2,000,000.00) Dollars, whichever is less, and
