WHEREAS, the Public Defender has requested that the Chair of the Ulster County Legislature be authorized to enter into an agreement with the New York State Division of Criminal Justice Services for the purpose of Ulster County's participation in the New York State Aid to Defense Project No. AD 21-1026-D00, for the period of April 1, 2021 through March 31, 2022; now therefore, be it
