WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Public Transportation; and

WHEREAS, pursuant to Resolution No. 218 of 2008, the Chair of the Ulster County Legislature executed a three-year agreement with the Town of New Paltz ending November 30, 2011 to provide public transit service between the Town of New Paltz, the Village of New Paltz, and the State University of New York at New Paltz (the "New Paltz LOOP"); and

WHEREAS, pursuant to Resolution No. 229 of 2011, Resolution No. 318 of 2014, Resolution No. 51 of 2017, and Resolution 458 of 2018, the Chair of the Ulster County Legislature executed various agreements with the Town of New Paltz to continue to provide the New Paltz LOOP service; and

WHEREAS, operating funds have been approved in the 2020 Ulster County Budget to continue New Paltz LOOP services for the period beginning December 1, 2020 and ending June 30, 2021; and

WHEREAS, the Ulster County Director of Public Transportation is requesting the execution of a 7-month contract extension with the Town of New Paltz to continue the New Paltz LOOP public transit service for a term beginning December 1, 2020 and ending June 30, 2021 at an estimated operating cost of \$22,979.00; now, therefore be it
