WHEREAS, this resolution has been submitted at the request of the County Executive on behalf of the Department of Public Transportation; and

WHEREAS, the 2022-2027 Capital Improvement Program includes a project "UCAT Bus Replacement" in the amount of $\$ 20,620,093.00$ for such project; and

WHEREAS, a grant application will be submitted to the Federal Transit Administration to accept and administer Federal 5339 funding for fleet replacements and expansions in the amount of $\$ 752,403.00$; and

WHEREAS, as part of the Federal 5339 grant, UCAT will reallocate $\$ 752,403.00$ for the federal share for the purchase of two (2) additional battery electric buses (BEB) and up to eight (8) $100 \%$ electric, zero carbon support vehicles for the UCAT fleet; and

WHEREAS, the County match on the purchase of these vehicles is not to exceed $10 \%$ or $\$ 299,180.70$; and

WHEREAS, it is necessary to establish and fund such project in the amount of $\$ 2,991,807$; now, therefore be it
