Allocation Of Funds From The New York State Office Of Children And Family Services To Implement Safe Harbor Programming –

Department Of Social Services

Discussion: Chairman Lopez explained the Safe Harbor Program funding will

be used exclusively to expand and enhance services to raise awareness of the problem of sexual exploitation of children, and to provide services to address the needs of sexually exploited children. Legislator Belfiglio asked who will be providing the services for the Safe Harbor program, such as the Part-Time Coordinator and Respite Care. The committee clerk the next day posed the question to Deputy Executive Ken Crannell via email who conveyed the part time coordinator will be a contract employee with the Dept. of Social Services who are accepting applications at this time. The Respite Care will be provided by Family of Woodstock. The balance listed will be either done in

house or has not yet been awarded.

Text of Motion: Recommending Purchase Of Additional Evacu-Trac Chairs To

Provide For Safe Evacuation Of Handicapped Individuals From The

County Office Building

Discussion: Legislator Allen provided an overview of how he came to the

understanding of the need for additional chairs in the county building. Some committee members stepped away from the meeting room briefly to view the hallway Evacu-Trac Chair. Legislator's Lopez and Belfiglio remained in the meeting room and noted a quorum was not present and committee business could not be conducted until the committee members returned. Legislator Belfiglio for the record noted upon return of the members a quorum again was present. The meeting was suspended for 1 -1/4 minutes. After further committee review and discussion, Legislator Allen, the sponsor of the resolution withdrew the resolution for consideration at this time to allow for additional fact finding, legislative recommendations - an all encompass resolution - to include other county building locations potentially in need of the devices. Chairman Lopez offered his assistance if needed, to draft an all-inclusive/comprehensive resolution in a timely manner.

Old Business:

- <u>Safe Staffing Nursing</u>: Last month, Minerva Solla, New York State American Nurses Association (ANA) Representative came before the committee last month to promote awareness, and asked for Legislative support via a memorializing resolution. Legislator Provenzano expressed her support

resulting in the entire committee agreeing to sponsor a Memorializing "Safe Staffing Nursing" Resolution. The committee will reach out to Legislative Counsel.

Gateway Meals on Wheels Services: Earlier in the day Legislator Provenzano asked Ken Crannell who will be delivering the county meals. Ken conveyed the county invited the previous Prestige drivers – including the volunteer drivers to come back, whereas the county offered to pay the volunteers mileage. Also, Gateway has committed to sending in some professional staff along with drivers that will check in with the seniors upon delivery of meals. Legislator Belfiglio also contacted Gateway earlier in the day to inquire on behalf of a constituent that was interested in work.

New Business:

- Chairman Lopez advised the committee that former U.C. Legislator and current Highland, N.Y. Supervisor, Paul Hanset, will attend next month's meeting to update the committee on a reported Highland, cancer cluster. A report is due out this week.
- Dr. Carol Smith, Commissioner of the U.C. Department of Health and Mental Health, will also be in attendance to discuss a new tick borne illness antibiotic resistant.
- Committee members would like a Self- Insurance update to explain the principles behind self-insurance and how if effects Ulster County.

Adjournment:

There being no further business, a motion to adjourn was made by Legislator Litts, and seconded by Legislator Provenzano, all were in favor, and Chairman Lopez declared the meeting duly adjourned at 7:45 PM.
