Chair Collins drew the Committee's attention to letters sent to Catskill Mountain Rail Road regarding activity beyond the limits of their lease agreement and corresponding letter from the Catskill Mountain Rail Road to Deputy County Executive Amanda LaValle.

Legislator Sperry arrived at 4:40 PM.

Chair Collins called on Peter Karis, Open Space Institute (OSI) Vice President of Parks & Stewardship to give a presentation to the Committee on the state of the corridor and the costs and infrastructure improvements associated with Rail with Trail and Trail only options for the undesignated section of the corridor. Highlighted among these concerns are the width of the existing corridor, that any rail with trail would necessitate widening the trail, including both rock cut and the raised portions over wetland areas, as well as the narrowness of the bridges.

Mr. David Barra asked about proposed dual use of the trail. Mr. Kevin Smith asked if OSI calculated the anticipated increase of use following a hypothetical connection of the Empire State Trail with the Ashokan Rail Trail through this corridor. Ms. Star Nocro asked about safety and emergency service access to rail trails across the county. Mr. Ken Anello inquired about

costs associated with just trail use. Mr. Ernie Hunt asked about the cost of just rail use. Mr. Jeremy Swift asked about a trail crossing at Hurly Mountain Road to connect the O&W Trail with the Ashokan Rail Trail.

Following the close of the public questions, Chair Collins asked the Committee if they would like to begin discussion of the letters referenced earlier in the meeting. The Committee decided to discuss this topic at the next meeting.

The next meeting of the Ulster & Delaware Advisory Committee is scheduled for Thursday October 24, 2024 in Legislative Chambers.
