WHEREAS, pursuant to Section C-11(O) of the Ulster County Charter and Section A2-5(15) of the Administrative Code, the Ulster County Legislature shall have the power to approve the execution of certain contracts and amendments in the amount of \$50,000.00 or in excess of \$50,000.00 entered into by the County; and

WHEREAS, a contract amendment for execution by the County with Gateway Community Industries, Inc. has been submitted for approval by the Ulster County Legislature, which is described below:

C10-00610 - Amendment No. 2 to the Agreement for the Job Shop Program which provides employment readiness training and job searches for recipients of TANF. These services are required to comply with the Federal Personal Responsibility and Work Opportunity Act of 1996.
