

Authorizing The Chairman Of The Ulster County Legislature to Execute An Inter-Municipal Agreement With The County Of Oneida For Boarding Inmates At The Central New York Psychiatric Center – Sheriff’s Office

Chairman of the Law Enforcement and Public Safety Committee, Thomas J. Briggs, and Deputy Chairman Ronald G. Lapp, Jr. offer the following:

WHEREAS, the Ulster County Sheriff does not have the required facilities to house a psychiatric inmate; and

WHEREAS, the Oneida County Sheriff’s Office has the capacity to house psychiatric inmates at the Central New York Psychiatric Center; and

WHEREAS, Oneida County has indicated it will charge Ulster County One Hundred Sixty-Five Dollars (\$165.00) per day, per inmate for inmates boarded out to the Central New York Psychiatric Center Forensic Unit; and

WHEREAS, the term of the agreement is from January 1, 2017 and through December 31, 2019; now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to enter into an Agreement, and any amendments thereto, with Oneida County for security of Ulster County inmates boarded out to the Central New York Psychiatric Center at a cost of \$165.00 per day per inmate for a term beginning on January 1, 2017 and ending December 31, 2019, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney, in consultation with the Chairman of the Legislature and the Chairman and Deputy Chairman of the Law Enforcement and Public Safety Committee,

and move its adoption.
