WHEREAS, the present lease agreement between the County and Astor Services for Children & Families, 6339 Mill Street Rhinebeck, NY 12572, for offices located at 50 Center Street, Ellenville, NY (the "Premises") will expire on December 31, 2018, and

WHEREAS, the Commissioner of Public Works has requested the Chairman of the Ulster County Legislature to enter into a lease agreement with Astor Services for Children & Families to lease 1,230 square feet of office space on the first floor of the Premises, for a five-year term beginning January 1, 2019 and ending December 31, 2023, at a cost of \$11.00/square foot, totaling \$13,530.00 annually, with all utilities and taxes included; now, therefore be it,

RESOLVED, that the Chairman Of The Ulster County Legislature is hereby authorized to execute a lease agreement and any amendments thereto, with Astor Services for Children & Families, 6339 Mill Street Rhinebeck, NY 12572, for offices located at 50 Center Street, Ellenville, NY, for a five-year term beginning January 1, 2019 and ending December 31, 2023, at a cost of \$11.00/square foot, totaling \$13,530.00 annually, with all utilities and taxes included, as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney,
