WHEREAS, this Resolution has been submitted at the request of the County Executive on behalf of Ulster County Area Transit (UCAT); and

WHEREAS, Ulster County is a designated recipient of funding through the Federal Transit Administration's (FTA) allocations of funding from the American Rescue Plan (ARP) Act enacted on March 11, 2021, which directly allocated funding to UCAT based on urbanized area formula funding; and

WHEREAS, funding from this grant would allow UCAT seek reimbursement for operating expenses incurred in response to COVID-19; and

WHEREAS, the total funding available to UCAT is \$1,310,895.00 at 100% federal share; now, therefore, be it

RESOLVED, that the Ulster County Legislature hereby supports and authorizes the grant application to the FTA for ARP Act funds; and, be it further

RESOLVED, that the County Executive is hereby authorized to execute any required applications or agreements, and any amendments to any documents, to accept the funding agreement with the FTA,

and move its adoption.
