WHEREAS, an insurance recovery totaling \$20,966.00 has been received in connection with a Sheriff's URGENT Division 2014 Ford F150 (Check # 0000102106 dated 8/8/19 for \$20,966.00 lost in an accident on 6/11/19); and

WHEREAS, the Ulster County Sheriff submits to have the following funds moved to the URGENT Vehicle line from the Self Insurance – Insurance Recoveries Revenue Line; and

WHEREAS, the funds will be used to cover the expense associated with the replacement of the vehicle, which was expended from the URGENT Forfeiture vehicle line; now, therefore, be it
