WHEREAS, the County solicited, through its RFP No. RFP-UC22-040, proposals for the development of an Ulster County Reuse Innovation Center Planning Study; and

WHEREAS, the firm Sustainable Hudson Valley was a successful proposer with a proposed project budget of $\$ 73,570.00$; and

WHEREAS, it is now necessary to establish and fund Capital Project No. 646 in the amount of $\$ 73,570.00$; and

WHEREAS, the Director of the Department of the Environment requests that Capital Project No. 646 be established and funded in the amount of $\$ 73,570.00$; and

WHEREAS, based upon examination by the Ulster County Legislature, said Capital Project constitutes a Type II action as defined under Sections 4.5.11 of the County of Ulster's State Environmental Quality Review Act (SEQRA) Type II List, which was adopted pursuant to Resolution No. 118 dated April 20, 2010; now, therefore be it
