WHEREAS, this resolution has been submitted at the request of the County Executive on behalf of the Department of Public Works; and

WHEREAS, the Wilbur Bridge (BIN 3346430) carries Bennett Road over the Rondout Creek in the Town of Wawarsing; and

WHEREAS, Capital Project No. 596 was established pursuant to Resolution No. 358 dated August 17, 2021, in the amount of $\$ 85,000.00$ for design phase of the Wilbur Bridge in the Town of Wawarsing, and

WHEREAS, the original plan was to remove the bridge, but a review of improvements required to allow for alternative routes was found to be more expensive than replacing the bridge; and

WHEREAS, based upon examination by the Ulster County Legislature, the County's funding of this Project constitutes a Type II action as defined under Sections 4.5.5 of the County of Ulster's State Environmental Quality Review Act (SEQRA) Type II List, which was adopted pursuant to Resolution No. 118 dated April 20, 2010; and

WHEREAS, Ulster County has determined that this funding action does not pose a significant potential environmental impact and may be progressed as a Type II action in accordance with 6 NYCRR Part 617 of SEQRA, and does not require any further determination or procedure under SEQRA; and

WHEREAS, the Commissioner of Public Works requests that Capital Project No. 596 be amended to increase the funding available for construction, construction inspection, and right of way acquisition services in the amount of $\$ 1,832,059.00$ for a total project cost of $\$ 1,917,059.00$; now, therefore be it
