WHEREAS, this resolution has been submitted at the request of the County Executive on behalf of the Ulster County Department of Mental Health; and

WHEREAS, the Ulster County Department of Mental Health has received notification from the New York State Office of Mental Health (OMH) for increased funding for Cost-of-Living Adjustments (COLA), as per the 2024 New York State Office of Mental Health (OMH) State Aid letter dated July 31, 2024; and

WHEREAS, to reflect the increased funding, an amendment of the 2024 budget is necessary to increase the approved operating budget; and

WHEREAS, there is no increase in County Contribution as a result of these modifications; now, therefore, be it
