WHEREAS, the approved 2024 – 2029 Capital Improvement Program includes a project “Sheriff – Jail Kitchen/Laundry Equipment” with an annual appropriation of \$50,000.00 in 2024 and \$100,000.00 in subsequent years, to replace costly kitchen and laundry equipment that is original with building; and

WHEREAS, the Ulster County Sheriff has obtained bids for jail kitchen equipment replacements in the amount of \$68,730.00; and

WHEREAS, the submitted request anticipates contingency for unanticipated costs of \$6,400.00; now, therefore be it
