The presiding officer of the Environmental Management Council shall be chosen annually by its members from among their members but shall not be an employee of the County of Ulster. Members of the Ulster County Environmental Management Council shall receive no compensation for services rendered but shall be entitled to their reasonable and necessary expenses incurred in the performance of their duties, within appropriations made for such purposes;" and

WHEREAS, the Town Board of the Town of Wawarsing has recommended the appointment of Sarah Underhill to the Environmental Management Council; and

WHEREAS, the County Executive has appointed the following individual to serve on the Environmental Management Council for the term indicated:
