Deputy Executive Chair Greene recognized Amanda LaValle to discuss the operational role the Department of the Environment assumes and using caution in considering county resources and staffing. Legislator Erner requested that this resolution be passed to set a public hearing. Hearing no further discussion, Chair Greene called the question.
