**Resolution No. 305** – Approving The Execution Of A Contract Amendment For \$56,000.00 \$37,509.50, Causing The Aggregate Contract Plus Amendment Amount To Be In Excess Of \$50,000.00, Entered Into By The County – C & S Engineers, Inc. – Department of Public Works

# **Resolution Summary:**

This Resolution approves contract amendment #2 to expand the scope of services to include additional site visits, new topographic survey at a new site, additional geotechnical investigations additional balloon floats, additional visual stimulation additional project meetings (County), meeting additional permitting requirements, additional boundary surveying, and expanded site concept drawings and increase the not-to-exceed amount for the Ulster County Public Safety Radio Tower at Tonche Mountain. 100% State funded. The amended term is 6/1/23 – 8/15/23, and the amended amount is \$56,000.00, for a total amount of \$140,941.50.

**Resolution No. 309** – Placing A Spending Cap Of \$XX,XXX,XXX.00 On All Costs Related To The Proposed Government Operations Center At Paradies Lane In New Paltz

**Resolution Summary:** This Resolution places a mandatory spending cap on the total amount of County funds expended for all costs related to the proposed Government Operations Center, including Capital Project 607, at \$XX,XXX,XXX.00.

#### Discussion:

Chair Hansut recognized Deputy Executive Kelly to explain that a 30% design was to provide insight on the project budget, and that this project is long overdue and not out of scale for the level of emergencies the County manages. Deputy Executive Kelly expressed concern at the placing of caps on a project that has used many resources to come to fruition, and encouraged the use of legislative roles to manage appropriations along the project process.

Legislator Uchitelle expressed concern and frustration about the purpose of the Resolution and suggested discussion with the sponsor to gain more insight.

Legislator Fabiano agreed with Deputy Executive Kelly's points and recommended the Committee postpone the Resolution until the sponsor could further discuss it with the Committee.

Deputy Chair Hewitt agreed that he wanted to discuss the Resolution with the sponsor, inquired about the costs of the project site acquisition and how inflation is affecting the budget, and thanked the people who have worked on the project thus far.

Legislator Fabiano clarified that he was in opposition of the project site for some time, but expressed great support for the project.

Legislator Uchitelle expressed concern about the increasing costs of the project outside of the project site acquisition.

Chair Hansut expressed inquiries to ask the sponsor, including if the cap includes grants or non-county funding sources, and what the consequences would be if the project went over the cap.

Deputy Chair Hewitt inquired about when more detailed project information would become Available, and Deputy Executive Kelly explained that by the fall season there would be more granularity about the project, Senator Gillibrand will advocate for federal assistance for the project, and that other avenues of revenue and cost avoidance for the project are being discussed on a rolling basis.

Chair Hansut recommended that the Committee take no action on the Resolution.

Legislator Uchitelle expressed a previous concern about the financial impact of the Resolution, stating he felt comfortable advancing it because the cost was included in the budget.

**Resolution No. 352** – Amending Capital Project No. 482 – Countywide Radio System – Amending The 2023 Capital Fund Budget – Department Of Emergency Services

Resolution Summary: This Resolution amends Capital Project No. 482 for the County Wide Radio System in the amount of \$299,999.00 on Land Mobile Radio Systems changes to include: added civil work to improve and develop the Kingston Shelter site, added civil work to accommodate the LMR system equipment, generator, and transfer switches, adding a generator and transfer switches to power aforementioned equipment in the event of a power outage, adding Nokia SR-X routers to direct and control site system data, and VESTA changes to include: adding two VESTA positions for Ulster Primary location, adding four IP phones for Ulster Primary location, adding a Peripheral Kit for the Ulster Primary Location, adding routers and switches for Highland, and adding Operating System migration.

# **Discussion:**

Chair Hansut recognized Director Erichsen to provide background information on the Resolution, including the change order to the contract with Motorola.

Chair Hansut recognized Legislator Erner to inquire if the facilities that use the mentioned equipment will move to Paradies Lane, and Director Erichsen explained that the facility will be relocated though the tower site will not, and that the tower site required several upgrades.

Deputy Chair Hewitt inquired about the whereases in the Resolution, and Director Erichsen explained that the whereases amend the Capital Project over the years. Legislator Uchitelle and Director Erichsen discussed that many amendments to the Capital Project were grant funded.

**Resolution No. 354** – Authorizing The Chair Of The Ulster County Legislature To Execute An Agreement With Ulster County Board Of Cooperative Educational Services (BOCES) To Provide Two (2) Deputy Sheriff's As School Resource Officers To Three (3) BOCES Locations – Ulster County Sheriff

**Resolution Summary:** This Resolution authorizes the Chair of the Ulster County Legislature to sign an agreement with Ulster County BOCES to provide two Deputy Sheriffs to serve as School Resource Officers in BOCES locations in Port Ewen, Saugerties and Ulster Park for the term of July 1, 2023 through June 30, 2024. The not-to-exceed contract amount is \$232,704.74

#### **Discussion:**

Chair Hansut recognized Sheriff Figueroa who expressed staff retention challenges and provided background information on the Resolution, including that a School Resource Officer (SRO) is presently at BOCES.

Legislator Bowen expressed concerns about the SRO program and her intention to discuss those concerns with the SRO trainer.

Sheriff Figueroa explained that the requests for increased SROs came from BOCES students' parents and shared information about the current SRO at BOCES.

Legislator Uchitelle expressed gratitude for the Sheriff and SRO work.

Legislator Bowen discussed the different roles played by school staff and faculty.

Chair Hansut expressed support for the SRO program due to her employment experience.

Deputy Chair Hewitt expressed concern about SROs holding weapons.

Sheriff Figueroa explained that schools have the option to hire armed security guards who are not trained law enforcement officers.

**Resolution No. 355** – Approving The Execution Of A Contract Amendment For \$11,858.00, Causing The Aggregate Contract Plus Amendment Amount To Be In Excess Of \$50,000.00, Entered Into By The County – New York Communications Company, Inc. – Ulster County Sheriff

**Resolution Summary:** This Resolution approves contract amendment #2 to increase the number of months used to calculate the amount in the prior amendment and add four additional radio packages to the remaining forty-three months of the Criminal division radio lease. 100% County

funded. The amended term is 2/1/22 - 12/31/26 and the amended amount is \$11,858.00, for a total amount of \$624,681.00.

#### **Discussion:**

Chair Hansut recognized Sheriff Figueroa to provide background information on the Resolution, including that this is for an extension of the contract for four radios.

Legislator Uchitelle expressed concern about the amount of NYCOMCO contracts and Deputy Executive Chris Kelly explained that there is not another company that can be contracted, including that an analysis of these contracts will provide insight into how these purchases are financed.

Sheriff Figueroa discussed his work in consolidating a number of NYCOMCO contracts and explained the benefit of easily upgrading leased technology.

Deputy Chair Hewitt and Deputy Executive Kelly discussed opportunities to expand competition for contracts through the Economic Development Department.

Legislator Erner and Sheriff Figueroa discussed the cost benefits of easily upgrading leased technology.
