**Authorizing The County Of Ulster To Dedicate The 2nd Floor Of  
The County Office Building In Memory Of Nina Postupack**

Legislator Greg McCollough offers the following:

WHEREAS, pursuant to Resolution No. 370 dated October 21, 2014, the Ulster County Legislature established a policy for the naming of county-owned assets; and

WHEREAS, the 2<sup>nd</sup> Floor of the County Office Building, where the Ulster County Clerk's Office is located, is a county-owned asset; and

WHEREAS, pursuant to the policy for naming of county-owned assets, a public hearing was held on Tuesday, January 14, 2025 at 6:40 PM in the Legislative Chambers, Ulster County Office Building, 6th Floor, 244 Fair Street, Kingston, New York, to ensure public input on the matter was considered; and

WHEREAS, the people of Ulster County have experienced a significant loss by the passing of Nina Postupack, who served as the Ulster County Clerk from 2005-2024; and

WHEREAS, in 2006, Nina Postupack made history and became the first woman elected to the office of Ulster County Clerk, and the first woman to be elected to a County-wide office; and

WHEREAS, the Ulster County Legislature believes it is fitting and appropriate to formally honor the memory of Nina A. Postupack; now, therefore, be it

RESOLVED, that the 2nd Floor of the County Office Building shall be dedicated as, "The Ulster County Clerk's Office and Nina Postupack Historical Center,"

and move its adoption.
