Chairman of the Ways and Means Committee, John Gavaris, and Deputy Chair Kenneth J. Ronk, Jr. offer the following:

WHEREAS, this Resolution has been submitted at the request of the County Executive on behalf of the Department of Finance; and

WHEREAS, the Town of New Paltz, a municipal corporation, wishes to purchase parcels of County-owned property hereinafter described, which were acquired by the County by reason of nonpayment of taxes; and

WHEREAS, said parcel # 36 of the 2021 Public Auction, listed as 11.50 acres, wetlands, N. Ohioville Rd., in the Town of New Paltz, section, block and lot number 87.5-2-17 has unpaid taxes in the amount of \$3,545.00 dating back to the year 2016; and

WHEREAS, prospective purchaser of parcel # 36 has bid \$500.00, the upset price as determined by the Ulster County Real Property Tax Service Agency, and it is their intent to acquire this property for public use and benefit; and

WHEREAS, said parcel # 37 of the 2021 Public Auction, listed as 9.00 acres, wetlands, N. Ohioville Rd., in the Town of New Paltz, section, block and lot number 87.5-2-18 has unpaid taxes in the amount of \$2,988.00 dating back to the year 2016; and

WHEREAS, prospective purchaser of parcel # 37 has bid \$500.00, the upset price as determined by the Ulster County Real Property Tax Service Agency, and it is their intent to acquire this property for public use and benefit; and

WHEREAS, said parcel # 38 of the 2021 Public Auction, listed as 5.20 acres, wetlands, Plutarch Rd., in the Town of New Paltz, section, block and lot number 87.5-3-2.212 has unpaid taxes in the amount of \$3,409.00 dating back to the year 2013; and

WHEREAS, prospective purchaser of parcel # 38 has bid \$50.00, the upset price as determined by the Real Property Tax Service Agency, and it is their intent to acquire this property for public use and benefit; and

WHEREAS, the prospective purchasers shall be responsible for the 2021-22 school tax and all subsequent tax levies; and

WHEREAS, these conveyances constitute Type II actions under section 4.1.5 of the County of Ulster’s State Environmental Quality Review Act (SEQRA) Type II List that was adopted in Resolution No. 118 on April 20, 2010; and

WHEREAS, as per section 3 of the County’s Type II List, these actions do not pose a significant potential environmental impact and may be progressed as Type II actions in accordance with 6 NYCRR Part 617 of SEQRA; now, therefore, be it

RESOLVED, that the Ulster County Legislature hereby finds and determines that the property described herein and which is intended to be conveyed herein is appropriate for conveyance to the Town of New Paltz for municipal purposes; and, be it further

RESOLVED, that the Town of New Paltz shall not name the subject property after any political figure; and, be it further
