WHEREAS, this resolution has been submitted at the request of the County Executive on behalf of the Department of Public Works; and

WHEREAS, a Project for the Bridge Replacement of Zena Road (CR 30) over Sawkill Creek, BIN 3346510, PIN 8761.76 (the "Project" is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs such program to be borne at the ratio of 80% Federal funds and 20% non-federal funds; and

WHEREAS, Resolution No. 305 adopted by the Ulster County on July 18, 2017 approved and agreed to advance the Project by making a commitment of 100% of the non-federal share of the costs of preliminary engineering and right-of-way incidental work in the amount of \$191,000.00; and

WHEREAS, Capital Project No. 505 was further amended pursuant to Resolution No. 175 dated May 15, 2018, in the amount of \$83,409.00 for a total project cost of \$274,409.00; and

WHEREAS, Capital Project No. 505 was further amended pursuant to Resolution No. 370 dated September 20, 2018, in the amount of \$10,000.00 for a total project cost of \$284,409.00; and

WHEREAS, it was subsequently found necessary to undertake additional preliminary engineering work not contemplated in the original agreement authorized by the previous Resolutions; and

WHEREAS, it has been found necessary to increase the federal and non-federal share of costs for the additional preliminary engineering work for the project; and

THEREFORE, the Ulster County Legislature, duly convened does hereby
