

**Approving The Execution Of A Contract For \$1,938,508.00 Entered Into By The County – Family Of Woodstock, Inc – Department Of Social Services**

Chair of the Health, Human Services and Housing Committee, Eve Walter, and Deputy Chair Craig V. Lopez offer the following:

WHEREAS, pursuant to Section C-11(O) of the Ulster County Charter and Section A2-5(15) of the Administrative Code, the Ulster County Legislature shall have the power to approve the execution of certain contracts and amendments in the amount of \$50,000.00 or in excess of \$50,000.00 entered into by the County; and

WHEREAS, a contract for execution by the County with Family of Woodstock, Inc has been submitted for approval by the Ulster County Legislature, which is described below:

2023-27 - operation of two (2) homeless shelters as follows: a. The Darmstadt Residence, a nineteen (19) bed shelter located at 40 Thomas Street, Kingston, New York, which provides emergency housing and related Services for individual adults who are age eighteen (18) or older and does not accommodate children. b. The Family Inn, a twenty-seven (27) bed shelter located at 38 Thomas Street, Kingston, New York, which provides emergency housing and related Services for families.  In addition to providing shelter, the Firm provides shelter residents with case management Services, meals and transportation as approved by the Temporary Assistance Division of DSS for up to ninety (90) days per resident.	33% Federal 15% State 52% County	Sole Source	1/1/23 - 12/31/23	\$1,938,508.00
