Chair of the Public Works, Capital Projects and Transportation Committee, Kathy Nolan, and Deputy Chair Herbert Litts, III offer the following:

WHEREAS, this resolution has been submitted at the request of the County Executive on behalf of Ulster County Area Transportation (UCAT); and

WHEREAS, this project includes the purchase of Rolling Stock to replace existing Rolling Stock that is over the useful life; and

WHEREAS, a grant application has been submitted and approved by the New York State Department of Transportation for the purchase of fleet replacement rolling stock in the amount of \$500,000.00; and

WHEREAS, a grant application has been submitted and approved by the Federal Transportation Administration for the purchase of fleet replacement rolling stock in the amount of \$500,000.00; and

WHEREAS, there is no match for the County of Ulster; and

WHEREAS, the County of Ulster desires to advance this project by making a commitment to receive 100% of funding from federal aid for the purchase of rolling stock for bus replacements; now, therefore be it

RESOLVED, that the Ulster County Legislature hereby approves the Project; and, be it further

RESOLVED, that the Ulster County Legislature hereby authorizes the County of Ulster to accept state aid and federal aid for the purchase of this project; and, be it further

RESOLVED, that the sum of \$500,000.00 is hereby appropriated from serial bond funding and made available to cover the cost of purchasing replacement rolling stock in this Project; and, be it further
