WHEREAS, pursuant to Section C-11(O) of the Ulster County Charter and Section A2-5(15) of the Administrative Code, the Ulster County Legislature shall have the power to approve the execution of certain contracts and amendments in the amount of \$50,000.00 or in excess of \$50,000.00 entered into by the County; and

WHEREAS, a contract for execution by the County with Robert G. Relph Agency, Inc., d/b/a Relph Benefit Advisors has been submitted for approval by the Ulster County Legislature, which is described below:

2023-100 - administration of health insurance benefits for employees and retirees of Ulster County Government including: A. negotiating and securing medical plans, prescription plan(s), vision plan, dental plan, stop loss plan, flexible spending account(s) and any other plan as needed for the County (Administration of health care benefits) B. providing all support necessary for the administration of Ulster County's Self-Funded Medical and Prescription programs and fully insured products C. furthering the effort to reduce the total cost of health care and all costs associated with the entire health insurance program D. analyzing health plan cost trends in relation to peers and national benchmarks E. investigating, evaluating and providing recommendations for innovative programs and suggestions to improve Ulster County health care insurance programs for its employees and retirees F. advisement for a Union environment regarding the best course of action to effect incremental changes to the health insurance program that benefits employees, dependents and overall costs G. providing a monthly status report of expenses to budget, reports demonstrating breakdown of health plan expenditures, reviews of health plan expenditures	100% County	RFP	1/1/23 - 12/31/25	\$630,000.00
