RESOLVED, that the Chair of the Ulster County Legislature, or his designee, is hereby authorized to enter into an agreement, and any amendments thereto, with the New York State Office of Indigent Legal Services for the purpose of Ulster County’s participation in Distribution #5, Contract No: C000751, for the period 01/01/2015 through 12/31/2017, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney in consultation with the Chair of the Legislature and the Chair and Deputy Chair of the Law Enforcement and Public Safety Committee,
