WHEREAS, the approved 2023-2028 Capital Improvement Program included the Roof Replacement and Exterior Site Work projects; and

WHEREAS, DASNY provided a Work Order 2019-002A that is needed in funding for construction services of the Vanderyn Hall Main Entry Doorway Replacement, related to the Campus Roofs Capital Project No. 493 - Door Replacement; and
