Chairman of the Health, Human Services and Housing Committee, Abe Uchitelle, and Deputy Chair Craig V. Lopez offer the following:

WHEREAS, pursuant to Section C-11(O) of the Ulster County Charter and Section A2-5(15) of the Administrative Code, the Ulster County Legislature shall have the power to approve the execution of certain contracts and amendments in the amount of \$50,000.00 or in excess of \$50,000.00 entered into by the County; and

WHEREAS, a contract for execution by the County with Family Services, Inc. has been submitted for approval by the Ulster County Legislature, which is described below:

2024-17 - operate a family education program in Ulster County (the "Program"), which will provide education to families determined to be at the highest risk for child placement, or in need of intervention and stabilization due to a current crisis (the "Family" or "Families"). The Program shall include intensive strength-based and family-focused approaches to provide home-based parent education and supportive counseling.
