WHEREAS, this resolution has been submitted at the request of the County Executive on behalf of the Ulster County Department of Emergency Communications / Emergency Management; and

WHEREAS, the Director of Emergency Communications / Emergency Management requests that the Chair of the Ulster County Legislature be authorized to enter into an agreement (C190323), and any amendments to the agreement, with the New York State Division of Homeland Security and Emergency Services for the contract period from September 1, 2023, through August 31, 2026, in the amount of \$230,463.00; and

WHEREAS, these funds are part of the FY23 State Homeland Security Program (SHSP); and

WHEREAS, this funding originates from the United States Department of Homeland Security and passes through New York State via the State Homeland Security Program; and

WHEREAS, the State Homeland Security Program supports planning, equipment, training, and exercise needs associated with preparedness and prevention activities for terrorist events using weapons of mass destruction involving biological, nuclear, incendiary, chemical, explosive, and radiological materials; and

WHEREAS, part of the grant award has already been budgeted in the Emergency Management budget in the amount of \$74,801.00; and

WHEREAS, the other part of the grant will need to be added to the 2024 County Budget award in the amount of \$155,662.00; and
