

Authorizing The Chairman Of The Ulster County Legislature To Execute An Agreement For The Maintenance Of Facilities For The Ulster Performing Arts Center For The 2017 Appropriation – Legislature

Chairman of the Legislative Programs, Education and Community Services Committee, Mary Wawro, and Deputy Chairman David B. Donaldson offer the following:

WHEREAS, performing arts are an important component of our cultural heritage, and the many performances arranged by the Ulster Performing Arts Center attract Hudson Valley County residents as well as travelers to see a broad range of entertainment for the community; and

WHEREAS, pursuant to County Law Section 224 (13), the Ulster County Legislature appropriated to the Ulster Performing Arts Center the sum of \$18,750.00 in the 2017 Ulster County Budget for the maintenance of facilities; and

WHEREAS, pursuant to County Law Section 224 (13), in order to receive such funds, the Ulster Performing Arts Center must submit to the Ulster County Legislature a verified accounting of disbursements to be undertaken, and to the Commissioner of Finance, a Memorandum of Receipt signed by the principal officer; and

WHEREAS, the Ulster Performing Arts Center will receive payment in the amount of \$18,750.00, in accordance with the terms specified in an agreement with the County of Ulster and the Ulster Performing Arts Center and will return any unexpended funds as of December 31, 2017, along with a certified accounting of expenditures to the Commissioner of Finance; now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an agreement in the amount of \$18,750.00, for the maintenance of facilities for the Ulster Performing Arts Center, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney, Counsel to the County Legislature, Chairman of the County Legislature, and the Chairman and Deputy Chairman of the Legislative Programs, Education and Community Services Committee; and, be it further
