RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute a three-year contract (Contract No. C029747) and any amendments thereto, for the period from October 1, 2014 through September 30, 2017, in the amount of \$76,254.00, with the New York State Department of Health to continue the CSHCN Program, in the form as filed with the Clerk of the Ulster County Legislature or modified with the approval of the County Attorney; and, be it further

RESOLVED, that if funding for this program is eliminated, the program will be eliminated as well,
