RESOLVED, that the Ulster County Legislature respectfully requests these two individuals (Mr. Stanley and Mr. Bernholz), upon their appointment, report annually to the Chairman and Deputy Chairman of the Economic Development, Tourism, Housing, Planning and Transit Committee regarding their and the Community Advisory Panel's actions; and be it further
