WHEREAS, the Ulster County Legislature passed Resolution No. 78 of 2023 establishing and funding capital project Number 659, subsequently renumbered to Capital Project Number 674, in the amount of two million five hundred thousand dollars (\$2,500,000.00) to establish a program to partner with Ulster County municipalities and match up to 50% of the net cost of each solar infrastructure or EV charging project with a maximum contribution of \$100,000.00 per project; and

WHEREAS, the County and the Village of New Paltz (the "Village") desire to enter into an Intermunicipal Agreement (IMA) where the Village will be a recipient of one hundred thousand dollars (\$100,000.00) of Ulster County funds; and

WHEREAS the Village will be responsible under the IMA for administering a program to install solar panels at the Village of New Paltz Water Treatment Plant; now, therefore, be it
