WHEREAS, the Department of Probation administers the Crime Victim Assistance Program which aids victims and witnesses of crimes; and

WHEREAS, the Department of Probation has been awarded funding in the amount of $\$ 75,430.00$ for the period October 1, 2021 - September 30, 2022 which will provide funding to the current the Sexual Assault Crisis and Prevention Programs’ efforts in administering prevention, training, education, and support services to victims of sexual assault; now, therefore, be it
