WHEREAS, this Resolution has been submitted at the request of the County Executive on behalf of the Department of Health (DOH); and

WHEREAS, the Medical Examiner's Office is open 24/7 and requires constant staff coverage; and

WHEREAS, the Medical Examiner's Office currently has positions in the 2025 Adopted Budget for (1) part-time Medical Examiner, (1) part-time Deputy Medical Examiner and (2) full-time Deputy Medical Examiners (Medicolegal Investigation), and less than part-time, non-benefited pay of \$20,660.00; and

WHEREAS, the Department of Health cites that due to an increase in the average caseload there is a need to establish an additional full-time Deputy Medical Examiner (Medicolegal Investigation); and

WHEREAS, with increased staffing in Medicolegal Investigation, the part-time Medical Examiner's role would reduce to less than half time; and

WHEREAS, the incumbent part-time Medical Examiner is currently working ten (10) hours per pay period; and

WHEREAS, this staffing ensures sufficient coverage of the office, in-line with the needs of the county; and

WHEREAS, in order to reflect this, an amendment of the 2025 Ulster County Budget is necessary; now, therefore be it
