

Confirming Appointment Of Toni Roser As The Director Of The Department Of Transportation For The County Of Ulster

Referred to: The Public Works, Capital Projects and Transportation Committee (Chairwoman Petit and Legislators Erner, Fabiano, Litts, and Nolan), and The Ways and Means Committee (Chairman Gavaris and Legislators Cahill, Fabiano, Roberts, Ronk, and Walter)

Chairwoman of the Public Works, Capital Projects and Transportation Committee, Laura Petit, and Deputy Chair Dean J. Fabiano offer the following:

WHEREAS, pursuant to Section C-26(A) of the Ulster County Charter and Section A3-5(A) of the Administrative Code: *“Appointment of department heads. Except as otherwise provided in this Charter, the County Executive shall appoint, to serve at his or her pleasure during his or her term of service, or for such term as may be specified in this Charter, the head of every department or other administrative unit not administered by an elective official;”* and

WHEREAS, pursuant to Section C-26(B) of the Ulster County Charter and Section A3-5(B) of the Administrative Code: *“Appointment of department heads. The appointment by the County Executive of the head of each department or other administrative unit shall be subject to the confirmation by the County Legislature by vote of a majority of the whole number of members elected to that body, taken at a regular or special meeting;”* and

WHEREAS, pursuant to Section C-67(A) of the Ulster County Charter and Section A13-1(A) of the Administrative Code: *“There shall be a Department of Public Transportation, headed by a Director who shall be appointed by the County Executive on the basis of his or her experience and qualifications for office to serve at the pleasure of the County Executive, subject to confirmation by the County Legislature;”* and

WHEREAS, pursuant to aforementioned sections of the Ulster County Charter and the Administrative Code, the County Executive has appointed Toni Roser to the position of Director of the Department of Public Transportation for the County of Ulster; now, therefore, be it

RESOLVED, that the Ulster County Legislature hereby confirms the appointment of Toni Roser to the position of Director of the Department of Public Transportation for the County of Ulster effective immediately,

and moves its adoption.
