WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Social Services; and

WHEREAS, the Commissioner of the Ulster County Department of Social Services requests that the Chairman of the Ulster County Legislature be authorized to enter into an agreement (NYS Contract # C028142), and any amendments to the agreement, with the New York State Office of Children and Family Services for the Child and Family Safety Program, for the contract period February 1, 2018 through January 31, 2019, in the amount of \$208,720.00; and

WHEREAS, the funds will be used by the Multidisciplinary Team (MDT), Child Advocacy Center (CAC), and Child Fatality Review Team (CFRT) to improve coordination among law enforcement, child protective services, health care and other community agencies involved in child abuse investigations and the protection of abused and neglected children, and

WHEREAS, in order to reflect the increased funding an amendment of the 2018 budget is necessary; and

WHEREAS, no County contribution or matching funding is required; now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an agreement (NYS Contract # C028142), and any amendments thereto, with the New York State Office of Children and Family Services for the Child and Family Safety Program, in the amount of \$208,720.00, in the form as filed with the clerk of the Ulster County Legislature or as modified with the approval of the County Attorney; and, be it further
