**Resolution No. 437:** Approving The Execution A Contract For \$395,611.00 Entered Into By The County – Ulster County Economic Development Alliance, Inc. – Department Of Finance - ARPA

**Resolution Summary:** This resolution authorizes the execution of a contract with the Ulster County Economic Development Alliance, Inc. from August 15, 2022 to December 31, 2024 for administration of subaward of the SLFRF for the purpose of providing assistance to specific Ulster County small businesses and honor the awards made to certain small businesses that received awards under the Ulster County CARES II Small Business Assistance Program but were later deemed to be ineligible to receive funding under County Contract No. 2022-00000303 by utilizing a different program in the amount of \$395,611.00.
