ARPA Administration Project Reporting

Director of ARP Administration Nate Litwin introduced attendees who were present to aid in the presentation of project updates. William D'Arcy presented on the Green Home Retrofit and Workforce Development Project, explaining his credentials, what it's like to work with the homeowners, and where the project is currently in process. Kristen Wilson introduced herself and provided an overview of the Brownfields Project. Director of Planning Dennis Doyle supplemented the discussion on Brownfields, including the details of how Brownfields are identified, what the process for remediation is, and what limitations the County has. Deputy Director Wilson continued in discussing the Food Security and Access Project, including the work that Family of Woodstock has completed on the Project and what work is forthcoming, introducing Mr. Kevin Quilty from Community Foundations of the Hudson Valley. Mr. Quilty detailed the Organization's plan and qualifications for the continuation and completion of the Food Security and Access Project. Discussion pursued on the Agricultural Crisis Relief Project and its potential interaction with the Food Security and Access Project.

Director Litwin provided Committee members with an update on the Division's ARPA Project Tracker, including the status of the Crisis Stabilization Center Project, the Respite Houses Project, the Eviction

Services Contract, the Mental Health in Schools Project, and the Non-Profit Recovery and Resilience Project. Further discussion pursued on the terminology utilized within the tracker, the ability of Opioid Settlement Funds to supplement the Respite House Project, and on completed Projects.

ARPA Financial Tracker

Chair Criswell noted that there are no major updates to report on but that encumbrances for completed contracts will hopefully take place soon and will be displayed accordingly on the tracker once complete. Chair Criswell also noted that journal entries for revenue also need to be recorded. Deputy Clerk of the Legislature – Finance Amber Feaster explained where manual journal entries are necessary in the County's financial system. The Committee discussed an appropriate timeline for such actions to take place.

Chair Criswell expressed concern that the Committee has a number of projects currently in discussion and this movement would increase the difficulty of making those projects come to fruition. Discussion pursued on the technical aspects of the Resolution pertaining to the value of funds remaining on the Jail Demolition project. Legislator Maloney emphasized that the entry would ensure no ARPA funds are lost due to missing deadlines or due to the adoption of a claw back provision.
