#### **2022 External Audit of the Annual Financial Statements**

Chair Bartels introduced Melissa Szot and Christopher Kopf from PFK O'Connor Davies. Ms. Szot spoke from 3:05 PM to 3:37 PM to inform the Committee of the external audit's timeline, planning procedures, and areas of high risk. Chair Bartels confirmed that there are no consequences to the County missing the Office of State Comptroller's (OSC) deadline for the filing of the County's Annual Update Document (AUD). Deputy County Executive Chris Kelly explained that the Finance Department is currently undergoing a few personnel changes which includes the recent hiring of new individuals. Ms. Szot stated the firm would like to play a big role in the presentation and preparation of the statements, asking that questions are asked early and often throughout the process. Committee members discussed the flow of communication between the parties involved.

Ms. Szot explained the various risks associated with a standard external financial audit and how procedures are designed to minimize the identified risks. Moreover, Ms. Szot spoke to the specific areas of concern identified at this time and the audit's major focus areas, and answered questions regarding fraud interviews and new GASB pronouncements. Comptroller Gallagher asked for copies of the schedules that the external auditors are requesting. Further discussion pursued on areas of concern and currently ongoing investigations. Ms. Szot and Mr. Kopf answered Committee member questions.

**Discussion:** Chair Bartels acknowledged that a Request for Proposals (RFP)

Deputy County Executive Chris Kelly stated that the cheapest proposal exceeds the adopted budget by nearly a quarter and asked if the Committee wanted to appoint

members to the review committee.
