**Discussion:** Committee discussion ensued. Legislator Litts expressed the need for more eminent domain detail within the resolve section of the resolution not rail footage. After much committee discussion with Chris White, Legislator Litts proposed the following amendments to page 3 of the resolution.

(Additional language is bold, language removed is struck through)

"The proposed public Project is **.80 miles long and** located in the City of Kingston extending from Westbrook Lane by Kingston Plaza to Cornell Street in midtown Kingston along the abandoned Ulster & Delaware Railroad right-of-way.

Alternative A: This alternative would **utilize the existing Ulster and Delaware railroad alignment from I-587 to Westbrook Lane.** remove the tracks east of Westbrook Lane to the I-587 underpass (approximately 1,100 feet). This alternative meets the public purposes of the Project but was rejected because it would not allow tourism railroad passengers to load at the eastern end of Kingston Plaza.

Alternative B: This alternative would **deviate from the Ulster and Delaware railroad alignment and follow the interim trail to the south of that alignment for a distance of 800 feet to 1100 feet between Westbrook Lane and the I-587 underpass** retain at least 800 feet of track allowing tourism railroad operations to continue while improving site distances by the I-587 underpass. This alternative meets the public purposes of the Project and was determined to be the Preferred Alternative. The Project may reduce or eliminate the 300 remaining feet of track <del>proposed for removal</del> based on future Legislative determinations on the matter. "

#### **Discussion:**

Chair Woltman called upon Rick Remsnyder who provided a brief overview of our fourth-year working with Cubic, Inc. The county evaluated eight different agencies. Rick noted Cubic's work is superior, head and shoulders above others - very pleased with their work. They have redesigned the website and provide creative ads. 2018 tourism spending in Ulster County was \$654 million, up 11% and continues to rise while building our brand with this agency contributed to that. Occupancy tax was also up 22% going into the third quarter of 2019. Marc Rider noted this is the last and final amendment contract with this agency.
