Ulster County Resource Recovery Agency

Mr. Rose reported the UCRRA 10-year Local Solid Waste Management Plan(LSWMP) has been submitted to the New York State Department of Environmental Conservation (NYSDEC). NYSDEC has 120 days to respond and comment but Mr. Rose doesn't expect many changes because the UCRRA has been in contact with the NYSDEC as the draft LSWMP was developed.

After the UCRRA receives the NYSDEC approval letter or the changes NYSDEC requests are minor, the LSWMP will come to the Legislature for final approval. If NYSDEC requests major changes it will go to the UCRRA Board then back to NYSDEC.

Mr. Rose reminded the committee that the UCRRA purchased 75 acres adjacent to their current operation on Flatbush Ave. At the March UCRRA Board meeting, he expects a consultant to present site plan options that include expanding the composting operation, a residential drop-off

area and a new administration building that would allow them to create an educational center in the current administration building. The presentation will include the cost of these various options so the UCRRA Board can determine what options they will pursue.

Resolution Summary: This is a memorializing resolution opposing a fossil fuel powered facility in Newburgh, NY

Discussion: Legislator Bartels, sponsor of the resolution, explained the critical need for the Ulster County Legislature to weigh in on this project noting that the impacts go beyond Orange County. She discussed potential amendments to the resolution including add language about a just transition for workers, Ulster County Legislatures Climate Emergency declaration.

Legislator Bruno felt that this memorializing resolution needed to tone down the political rhetoric and focus on the facts.

The committee discussed these possible changes as well as Legislator Petit's request to expand the resolution to include the gas fired plant at Cricket Valley; concerns for any new facility to be built in a location proven to be vulnerable to flooding from tropical storms; the New York State Climate Leadership and Community Protection Act, (CLCPA) which would limit the plants operational life of this plant to about 20 years; and scenic impacts of the old plant and any new plant on the Hudson River view sheds.

Mr. Gordon felt the resolution in its current form was weak. He suggested sending the approved resolution to the siting board. He suggested the county could file for Article 10 intervenor funds.

Chairwoman Greene clarified that in this case, intervenor funding had already been awarded. She also said that the siting board initially did not list the CLCPA issue as a deficiency in the project but now they are addressing CLCPA.

Legislator Wawro suggested the resolution should note that several Ulster County municipalities like the Town of Saugerties have gone on record opposing the Danskammer plant.

Legislator Bartels expressed her willingness to change the language Legislators Bruno and Wawro mentioned in order to make the resolution more inclusive and invited other legislators who wanted to collaborate to contact her. She asked for a one month postponement.

Discussion: Mr. Doan told the committee the UCSW signed a new 5-year agreement with New York City Department of Environmental Protection (NYCDEP). This is the third such agreement. The work involves stream restoration and water quality improvement that benefits many of the local communities in the NYCDEP Watershed.

They are also involved in a regional Carbon farming project with other counties. 6 fars in Ulster County are participating. The pilot projects with help sequester carbon and they are using robust soil testing by Cornell Cooperative Extension to measure results. The project has an educational component.

Mr. Gordon raised questions regarding the contract and the work set forth in Schedule A. He felt it was a very thin statement of services and lacked any specifics. He suggested the Legislature might want more detail of where the money is going and perhaps get a list of specific streams and projects the money would be used for.

Legislator Bartels explained that this Legislative funding is not usually dedicated to specific projects but it is used to leverage all the work Soil and Water preforms. She suggested the committee have a conversation about all the projects Soil and Water undertakes and what potential services they can provide.

Chairwoman Greene asked if postponing the resolution for a month and asking Mr. Doan to come back with a more detailed report would be a problem. Mr. Doan indicate it would not be.
