Legislator Erner asked what the starting salary was. Director Koppenhaver responded that the homemaker aides are paid \$18.20/hour, which is more than mot aides in the industry.

Chair Uchitelle recognized Veterans Services Director Cozzupoli to give a brief update on the progress at the Veterans Cemetery. Director Cozzupoli explained that the money for the contract amendment is contained in the Capital Project budget, but the contract with the vendor needed amending to pay for the additional service. Chair Uchitelle asked what services the contract covers. Director Cozzupoli responded that the contract is for design but also onsite construction management services. He advised the members that the cemetery was on track for a May opening date. He added that the opening would not be held on Memorial Day to not detract from annual Memorial Day services by all of the community VFWs. He added that the Legislature would be sent invitations for the opening.

Legislator Erner asked if the issues raised by the local community were addressed. Director Cozzupoli responded that he had a follow up meeting with residents to discuss their issues with some very strong lighting that had been installed. He said they redesigned the lighting and all parties are satisfied. He added that the American Flag that will be flown at the cemetery will not be lowered each a=day and therefore requires to be lit 24 hrs. a day

Chair Uchitelle stated that the public hearing was held last month and many people attending to offer comments and support for the legislation. He advised the members that he would like to offer an amendment that resulted from one of the speakers at the public hearing. He asked the members to consider adding extremely low and very low income housing in addition to low and moderate income housing. He added that he believed that low income implies the inclusion of extremely and very low income, but did not object to the clarification.

Legislator Nolan stated her support for the clarification. Legislator Erner stated that there was a comment offered at the hearing regarding means testing sating that proof of eligibility outside of participation is=n a federal or state program can be difficult. Legislator Nolan suggested language referring stating a person eligible or deemed to be eligible to clarify.

Planning Director Doyle stated that the eligible language was added after Legislator Uchitelle reached out and that they believed the way it is written is expansive not restrictive.

Discussion:

Chair Uchitelle stated that he introduced legislation the previous year to allocate funding from the excess fund balance for housing programs. He added that discussions surrounding changes to the fund balance policy complicated things as it attempted to create an automatic mechanism to fill the fund. He explained that this resolution is essentially the same without making any changes to the fund balance policy, rather a one time allocation to the fund. He added that actual funding allocated can create an environment where the legislature can more aggressively bring for housing ideas. He advised the members that he spoke with the County Executive earlier in the day who expressed her support. He advised the members that she had included funding dedicated to addressing housing in the county during her state of the county address and explained that he was asking the members to postpone the resolution to allow her office to provide feedback and collaboration. He added that he wanted those discussions and feedback to take place in the HHSH committee as opposed to Ways and Means, and therefore preferred postponement.

Legislator Erner stated his support for the restoration of the amount to that included in last years budget discussions. He added that there was a technical amendment required to indicate which Commissioner specifically is responsible for accounting.

Director Doyle thanked the members for the postponement and stated that he believed everyone was on the same page and valued the cooperative environment, especially with millions of dollars at play. Chair Uchitelle stated that he was hoping that was one of the results of the discussion with the Executive's Office. Resolution Summary: This resolution established a policy to prioritize feeding Ulster County residents placed in emergency housing and directs the Purchasing Director to initiate an RHP for the service within 90 days of the Resolution's adoption.

Discussion:

Chair Uchitelle stated that this resolution came out of services a number of philanthropic organizations provided during the pandemic to help with some dire circumstances. He added that he began volunteering with Kingston Emergency Food Collaborative who delivered food to any family in need every day of the week. He noticed that many of the meals were delivered to people housed by DSS in emergency shelters/hotels. He stated that private philanthropy can't be counted on to provide for the county's residents in need and therefore advanced the legislation. He added that many times emergency accommodations do not have kitchen facilities and distances to food stores can be prohibitive, especially for the lacking transportation.

He explained that the resolution requires and RFP for the service be initiated. Legislator Nolan commented that the term "feeding" has a specific definition, especially in the medical community, and would suggest changing it to prioritizing food security or food stabilization. They also suggested providing the amenities that are lacking in the emergency accommodations such as refrigerators, microwaves or hot plates, and/or providing a shopping card to purchase food.

Chair Uchitelle thanked Legislator Nolan for the comments and stated that he would entertain an amendment to the title to change feeding to meals for as his intention was not to take over the entire nutritional needs of the individual. He added that he has numerous concerns with providing a shopping card including: lack of transportation, walking on unsafe/dangerous roads like Route 28, possibility of creating a benefits cliff issue by adding resources.

Legislator Erner expressed his support for the program. Legislator Stewart stated that a benefit to delivering the meals as opposed to a card is a method to guarantee that people get a nutritionally balanced meal rather than spending the card on unhealthy items. Chair Uchitelle stated that the resolution stipulates that the legislature was a seat on the RFP drafting process. Adding that he wanted to ensure that culturally appropriate food items be a criterion for the food. He advised the members that one of the meals prepared by Kingston Emergency Food Collaborative contained quinoa which many of the recipients were unfamiliar with and refused delivery of.

Legislator Petit stated that she would like the program expanded to boarding houses and seniors. Chair Uchitelle responded that unfortunately those residences do not count as emergency housing and could not be accommodated through this program as currently written. Legislator Nolan stated that they would prefer the program be more expansive than just delivering meals. They added that providing hot-plates which is done in new York City might be an idea.

Legislator Erner stated that if the members wished to go bigger a county emergency housing facility would be able to provide all of the suggested assistance. Chair Uchitelle recognized Commissioner Iapoce to offer any thoughts on the program.

Commissioner Iapoce suggested modeling the program on the meals on Wheels service which provides one meal a day, and be something that is not means tested, and is optional and fully funded by the county. He added that some clients may not be favorable to the meal delivery, and advised the members that all emergency accommodations have mini fridges and microwaves. He stated that the county can pay to have them installed if they are not provided. He stated that if the county was willing to fund the program the one meal a day would definitely help to supplement needs.

Resolution No. 134 – Supporting Freedom Of Choice In Relation To COVID-19 Shots

Resolution Summary: This resolution expresses opposition to policies that mandate COVID-19 vaccines for individuals by any local, state or federal government and encourages private businesses, institutions of education and religion, medical service providers, and non-government organizations to respect an individuals' choice regarding vaccination.

Discussion:

Chair Uchitelle recognized Resolution sponsor Legislator Hewitt. Legislator Hewitt stated that he didn't want to get into science surrounding vaccinations, he wanted to talk about choice. He added that bid pharma has

made hundreds of billions of dollars with the COIVD vaccine while dictating what people do with their bodies.

Legislator Nolan stated that they were troubled by a number of things in the resolution including: addressing only COVID-19 immunizations as a special case, advocacy language in the resolution which they did not feel was relevant in terms of addressing the use of immunizations, and addressing mandates absent of the consideration of public health and medicine. Legislator Petit stated he opposition to mandating immunizations as they do not provide immunity. She added that courts found it illegal for companies to require employees be vaccinated. Legislator Lopez stated that the resolutions doesn't address lawmakers and their part in it. Allowing pharmaceutical companies to line the pockets of lawmakers who create the policies that enable the companies to generate giant profits.

Chair Uchitelle stated his opposition to the legislation. He added that it singles out a single vaccine, adding that the narrative around it has been exploited by people who thrive on misinformation. He stated that throughout the pandemic an option to test was offered as opposed to being vaccinated, which he stated was often more effective than the vaccine because it kept people home when necessary. He commented that there are schools that don't require immunizations, adding that they also have seen resurgences of diseases like polio. He said he found the resolution divisive and emphasized his opposition.

Legislator Stewart had issues with the resolution and stated that public health is within the government's purview. He echoed the Chair's comments on misinformation and expressed his frustration with statements made at session and throughout the past three years and stated his opposition to the resolution.

Commissioner Smith agreed with comments of the Chair regarding misinformation. She added that politics should be taken out of public health and stated that in general vaccination has been the greatest benefit to public health in the last century. The members briefly discussed immunization versus cure.

Legislator Hewitt stated that he did not want the resolution to be divisive and felt it cold be improved. Legislator Nolan stated that the resolution should at least include all immunizations, adding that she appreciated the points about profit motive.

Chair Uchitelle asked if there was any other discussion and stated his readiness to call the question on the resolution.

Chair Uchitelle advised the members that Resolution No. 132 under Forthcoming Resolutions on the Agenda was withdrawn by the sponsor. Under Old Business hair Uchitelle advised the members that he was no action and considering withdrawing the resolutions as the matter has been not going well in the courts for lower municipal action.

Chair Uchitelle stated there as one more item on the agenda that came from a suggestion by Legislator Erner. He advised the members that the incident to be discussed occurred in Ellenville when he was the Chair of the Law Enforcement Committee, but the body cam footage was just released, the response involved a mental health call and he was glad to have the opportunity to follow up.

He invited Mental Health Commission MacDonald to update the members on the mobile Mental Health Response team. Commissioner MacDonald advised the members that the county funded a contract to have a dispatcher who was a clinician as part of the mobile mental health team sit alongside and help the 911 dispatchers learn to divert calls for individuals suffering from a behavioral challenge to the mobile mental health team. She stated that it is about the third cycle of contracting with ACCESS who has had an incredibly difficult time finding staff willing to sit in the 911 center. She added that the inconsistent hours a clinician was available did not lend itself to altering the workflow of the dispatchers. She advised the members that the regional rollout of 988 will present opportunities. She added that Dutchess County Health Line take callers from Ulster County, about 40/month, and are successfully linking them to services, including mobile mental health and the mental health offices.

Legislator Erner asked for an explanation of the differences between 911, 988, and 844. She explained 911 is the traditional line to call when assistance is needed, adding that there is a position for a clinician to be there to help dispatchers determine if diversion to mobile mental health is advised. 988 is the National Suicide Hotline, regional call center in Dutchess. The 844 number is directly to mobile mental health who will talk through an issue or decide to go out to the community, but is only available 10 - 10 Monday – Friday, 365 day/year.
