Chair Uchitelle recognized Deputy Executive Contreras, who shared with the Committee that the County may apply for additional grant funding to support large emergency efforts.

Legislator Petit inquired about the threshold of seniors eligible for the program, and Director Koppenhaver explained the prioritization schedule which serves to support food security for no-income and low-income seniors.

Chair Uchitelle requested that the Executive Office provide salary information for contract renewals.

Legislator Nolan inquired about the logistical possibility of a sliding scale food service, and Director Koppenhaver explained that Gateway offers meals for private sale that are tailored to specific dietary requirements, and that the program in this Resolution provides free meals to those who apply.

Legislator Erner asked for recommendations on how less single-use plastic could be used for these meals, and Director Koppenhaver explained that due to the COVID-19 emergency, meals are heated individually to limit exposure, and that the containers meals are heat-tolerant. Director Koppenhaver also shared with the Committee her goal of replacing the utensils used at congregate sites with reusable silverware and glassware.

# **Discussion:**

Chair Uchitelle recognized Commissioner Iapoce to provide background on the Resolution, including how this funding will reimburse Family of Woodstock for hotel reservation expenditures incurred during the 2022-2023 Code Blue season.

Chair Uchitelle inquired if the additional Code Blue warming center in Ellenville was the reason for the significant cost increase and Commissioner Iapoce explained that the Resolution was submitted for this amount in the event that the Ellenville warming center was established or in case of emergency hotel reservations during the Code Blue season, which is what happened. Mr. Berg described the reimbursement process.

Legislator Stewart inquired as to whether the Ellenville warming center was operational and Commissioner Iapoce explained that although a lot of effort was expended on locating a site in Ellenville, the attempt was unsuccessful, and will continue despite discovered challenges.

Legislator Petit asked if the population of homeless persons increased, and Commissioner Iapoce explained that the specific population has not varied greatly, and that the amendment reflects the costs incurred when housing individuals and families during low-temperature weather. Mr. Berg shared the experiences of supporting more people who are unable to find affordable housing, further exacerbating homelessness.

Chair Uchitelle asked if there was any other discussion and hearing none called for a vote in favor of the Resolution.

**Resolution Summary**: This Resolution approves a \$100,000 contract amendment for the thr term of 1/1/23 - 12/31/23 for "safe and appropriate emergency shelter including individuals who have been sanctioned for non-compliance, or individuals who are not the subject of a public assistance case." 100% County.

# **Discussion:**

Chair Uchitelle recognized Commissioner Iapoce to provide background on the Resolution, including the necessity of covering the costs Family of Woodstock incurs when housing people during Code Blue season that cannot be reimbursed.

Legislator Stewart inquired about the emergency housing application procedure during Code Blue season, and Commissioner Iapoce explained that emergency housing occurs outside of normal business hours when application assistance and follow-up can be provided. Mr. Berg expressed that some service users may choose to not complete an application. Deputy Executive Contreras explained that the Resolution amount is to take proactive action to reimburse Family of Woodstock if increased services are needed during Code Blue season.

Legislator Erner inquired if the Department of Social Services (DSS) could be reimbursed for 24-hour services, and Commissioner Iapoce explained that this change in procedure would require conversation with the CSEA union, as well as detailed how some individuals experiencing homelessness experience hesitance in collaborating with local government entities like DSS.

Legislator Nolan expressed the importance of increased supports for homeless people in residential settings like Samadhi and the consequences of continued use of motels for emergency housing. Commissioner Iapoce expressed optimism about alleviating homelessness with the support of the Crisis Stabilization Center, and Mr. Berg expressed belief that 24-hour operation of DSS would create a significant cost to the county.

Chair Uchitelle expressed support for the Resolution and inquired about the origin of cost figures, to which Commissioner Iapoce explained that a formula was used to arrive at the amount. Deputy Executive Contreras explained that the contract amendment is to be proactive about ensuring costs are covered for emergency housing.

Chair Uchitelle asked if there was any other discussion and hearing none called for a vote in favor of the Resolution.

**Resolution No. 330** – Dedicating Funding To Housing Affordability, Establishing A Policy For Its Use, And Authorizing The Release Of A Notice Of Funding Availability (NOFA) For 2023 – Department Of Planning

**Resolution Summary**: This Resolution creates an unassigned Fund Balance for Housing Affordability purposes in the initial amount of \$15 million, with funds appropriated pursuant to Proposed Local Law No. 2 of 2023.

# **Discussion:**

Chair Uchitelle explained that this Resolution is in connection to the recently held Special Health, Human Services & Housing Committee meeting and shared a brief review of amendments before the Committee, including the clarification of the role of the Finance Commissioner, and statements on the funding purpose of the Resolution, conformity with all New York State affordability guidelines, not using these funds to help projects meet existing requirements, and supporting emergency housing.

Legislator Nolan inquired about the qualification of boarding houses for this funding, as existing buildings can be used for emergency housing at a lesser cost than building new housing. Commissioner Iapoce discussed his concerns about funding boarding houses including necessary conditions and the definitions of boarding houses and what a unit in one is. Legislator Nolan expressed support for addressing and defining these concerns and adding to the housing stock. Director Doyle explained that the Elizabeth Manor boarding house is included in the rubric of emergency housing in the Resolution.

Chair Uchitelle discussed amendments including correcting local law references, clarification of the timing and procedure of the establishment of the board, the inclusion of a minority party appointed representative, accounting clarification, the inclusion of an annual report to the Legislature by the Finance Commissioner, requiring Legislative Resolutions to appropriate into the fund, not appointing staff to the board, the staggering and clarification of terms, the requisite of a budget amendment for the necessary funds, and the ability of the Finance Commissioner to establish investment gains for the fund. Chair Uchitelle expressed appreciation for the collaboration between Legislative staff and the County Executive's Office.

Chair Uchitelle recognized Director Doyle to express appreciation for the collaboration on the Resolution and discuss the impacts of tying this fund to an annual budgeting process while state and federal grant applications may have different timelines. Legislator Nolan recommended amending the Resolution to include application submission for funding as part of the annual budget process, or as needed.

Legislator Erner expressed concern about the lack of clear inclusion of a board member with lived housing instability experience. Legislator Nolan suggested including hortatory language to include this type of membership as an aspiration rather than a requirement to ensure functionality. Chair Uchitelle expressed concern about housing insecure people doing unpaid volunteer work. Legislator Erner expressed support of paying members of boards and commissions.

Legislator Erner inquired if this fund could be used to cover rent or mortgage payments of people who are nearly housing unstable. Further discussion ensued regarding the possibility of future rental affordability programs, the constitutionality of gifts, and existing housing subsidies.

Chair Uchitelle asked if there was any other discussion and hearing none called for a vote in favor of the proposed Resolution amendments.

Legislator Stewart requested clarification on an upcoming tour of emergency housing units and Chair Uchitelle clarified the informality of the tour and the lack of quorum concerns.

Chair Uchitelle recognized Director Doyle to discuss that the funding amount for the Housing Fund was decided based on other county's experience and success with similar programs, the importance of maintaining emergency housing stock, and the decision of the Supreme Court with respect to foreclosure sales.

Chair Uchitelle asked if there was any other old or new business and hearing none;
