Chair Uchitelle introduced O+ Festival Co-Founder Joe Concra. Mr. Concra thanked Chair Uchitelle for the invitation to speak to the committee about O+ Festival. He spoke about the founding of the festival in 2010 when he and some artist and health care providers began questioning what would happen if they took the money out of the systema and exchanged for health care. He advised the members that 2023 would mark the 13th year of the O+ Festival which has provided more than 6,000 primary care and 2,000 dental visits. He shared that just a couple of weeks ago a year round clinic was opened. They have been able to serve 225 people over a weekend and are hoping to double that number with the new clinic. He added that they are also building an exchange platform that people can use on their phone. He asked if the members had any questions.

Legislator Stewart asked how many doctors will participate in the program this year. Mr. Concra responded that they will have between 135 - 150 doctors and providers, including residents who need to satisfy their certification requirements. He added that alleviating at least some of a persons' medical costs helps to keep housing and studio rents within reach for many.

Legislator Stewart commented that Mr. Concra and O+ were recognized by HealthAlliance for their work. Mr. Concra briefly spoke about health insurance and connecting people seeking services with ACA navigators. He stated that the 2023 O+ Festival was about one month away.

Chair Uchitelle asked if there were any other questions and thanked Mr. Concra for his time.

Chair Uchitelle asked the Executive's Office of there were any updates. Deputy County Executive Contreras responded that they were waiting on guidance from the Treasury on whether a not-for=profit could take on the property and turn it into housing, either affordable, emergency, transitional, supportive, etc. She added that the treasurer would need to approve that as well as any transfer of the property. Legislator Stewart asked what the process was for looking at properties. Deputy Executive Contreras responded that they were in the process of securing a realtor.

Chair Uchitelle asked what the timeline was for hiring a relator. Planning Director Doyle advised the members that they had interviewed two firms and selected one, so he expected a contract to be entered into quickly. He added they were working through conflict issues with a single firm acting as the listing agent and buyers agent.

Legislator Petit asked about implications of taking no action or postpinning another month and questioned if RFPs had been drafted. Deputy Executive Contreras responded that they could not move forward without answers on the implications of the ARPA funding used to purchase the property. Legislator Petit questioned if Elizabet St was similar to the respite houses. Deputy Executive Contreras replied that the county was actively trying not to own the respite houses, but already owns Elizabeth St.

Chair Uchitelle asked if there were any further questions or discussion and hearing stated he was supportive of taking no action. The members agreed.

Chair Uchitelle stated that one of the resolution sponsors was present, asked if the Executive's staff had anything to add and hearing none recognized Legislator Roberts. Legislator Roberts stated that he was pleased to hear that the Executive's Office was thinking about selling it or giving it to a non-profit. He asked which it is? Deputy Executive Contreras stated that would depend on the response they receive from the Treasury. Director Litwin added that they had received some guidance, but it did not exactly address sale of the property and they were waiting on additional guidance. Legislator Roberts questioned they response delays and asked for an up or down vote on the resolution which would allow the Executive's office a month to get answers.

Legislator Nolan stated that they would normally support an up or down vote but questioned moving forward with a vote on the sale without information on the legality of the sale. They cautioned against moving forward with a vote on sale without legal clarity and would be more comfortable with postponement. Legislator Stewart stated that he agreed with legislator Nolan that a vote would be premature in the absence of the legal clarity. Chair Uchitelle stated that he was inclined to honor the sponsors request for a vote.

Chair Uchitelle recognized Director Litwin to explain the Resolution. Director Litwin explained that the resolution approves a revised recapture agreement to ensure the property remained affordable for 15 years and a mechanism for the county to recoup funding if the provisions were not met. He added that the County Attorney and RUPCO's attorney to work out the various funding sources. Legislator Erner commented that the organizational chart was confusing and that he would like the project manager to address the committee. He questioned the minimum agreement for affordability. Director Litwin responded that there would be multiple layers ensuring affordability even longer than the states.

The members briefly discussed the criteria for affordability and how the recently adopted local law came into play. Director Doyle stated the project will meet the requirements of the county law, adding that the project was funded with ARPA funds, not county finds, making it not subject to the law. Director Doyle stated that the criteria would be written into the regulations that govern the project. Legislator Erner asked if the affordability requirements could be written into the recapture agreement somewhere. The members discussed where the eligibility criteria could or should be added and hesitated to change the recapture agreement.

Legislator Erner asked if someone's income changes if they become disqualified from living there. Director Doyle responded that there are allowances for income level changes. He added there may be additional allowances in the agreement and that there are different income level units in the project.

Chair Uchitelle asked if there were any questions or discussion and hearing none called for a vote in favor of the Resolution.

Discussion:

Chair Uchitelle recognized DSS Commissioner Iapoce for some background. Commissioner Iapoce advised the members that the Resolutions relate to residential treatment facilities for adolescents that come into the care and custody of DSS or might be directed by Ulster County Family Court as a result of their being the subject of a court proceeding. Deputy Commissioner Wood added that some of the placements result from adolescents discharged from hospital or psychiatric hospitals who can not be placed in a traditional foster home. She advised the members that the contract amendments also reflect rate changes.

Legislator Stewart asked how many children are in the foster care system. Deputy Commissioner Wood responded that there are about 60 in the residential program and 100 more in some foster placement such as placement with families, kinship homes, relatives, family friends. She added that the intention is always to get adolescents out of the residential facilities. Legislator Stewart asked when they age out. Ms. Wood responded 18, but they can stay in until 21. She added that there is aftercare that agencies provide for 6 months after they leave, and the state does allow children over 18 to reenter one time. Legislator Erner questioned contracts for two out of county providers. Deputy Commissioner Wood responded that the county is responsible for paying school tuition for adolescents in residential care and that the placement is determined by the Special Education regulations.

Discussion:

Chair Uchitelle asked Legislator Erner if he had any updates on his conversations with the administration. Legislator Erner responded that a member of the public was present who had begun a petition in support of the measure. He added that he had a conversation with the Public Works Commissioner to explore use of the Fairgrounds. He shared that there were a few RVs that the county owns that are equipped with plumbing and that he was suggesting their use in some way. He stated that there were other ideas and locations being explored.

Legislator Nolan stated that no action may be the best course in this instance as well. They commented that the results of the space study being conducted may help inform the direction the Resolution takes. They added that the idea of equipping RVs with plumbing to provide shower opportunities could be pursued separately and did not necessarily require a policy. Legislator Erner commented that he spoke to the DPW Commissioner who shared Legislator Erner's frustration with how long it is taking to complete. He advised

the members that the Commissioner may be updating the Public Works Committee on its progress at their meeting.

Chair Uchitelle asked if there was any further discussion and hearing none asked the members if they were comfortable moving forward without acting on the Resolution. The members agreed.
