- 1. Mark Steinhoff, Chairman of the Village of Ellenville Planning Board: Mr. Steinhoff spoke on behalf of Jeff Kaplan, Mayor of the Village of Ellenville who could not be in attendance tonight. - 2. <u>Joe Stoeckeler</u>, <u>Village Manager of Ellenville former UC Legislator</u>: Mr. Stoeckeler recalled the Ellenville Hospital topic whereas debt was forgiven based on Legislative negotiations whereas they made an honest decision and voted from their gut. Chairman John R. Parete called upon District No. 8 Legislator Carl Belfiglio who is the legislative board member representative for the Ulster Prevention Counsel. Legislator Belfiglio provided an overview of how the council has evolved since its inception and spoke to prescription drug abuse. Legislator Belfiglio introduced Cheryl DePaolo, Director of the Ulster Prevention Council who noted their annual report can be viewed on their website. Ms. DePaolo made a presentation of the prevention council's progress with substance abuse – drop box locations, etc. Lori Rotolo, Community Prevention Specialist, provided literature, and introduced this year's winners of the Public Service Youth Media Contest. The winners were: Safiyyah Alston – Video, Chantel Price – Radio, Chris Kovalcik – Poster (Underage Drinking), Katherine Zenteno – Poster (Prescription Drugs), and Richard Rober – Poster (Marijuana & Animated Poster.)

Chairman John R. Parete called upon District No. 8 Legislator Carl Belfiglio and District No. 15 Legislator Thomas Briggs who presented a Pride of Ulster County to Chantel Price, Katherine Zenteno and Chris Kovalcik in recognition of winning the Ulster Prevention Council Public Service Youth Media Contest. Safiyyah Alston and Richard Rober were not able to be in attendance. All of the winners reside in the Ellenville School District.

PUBLIC COMMENT: There were (3) speakers signed up for public comment.

- 1. <u>Peter Fluchere</u>: The Catskill Mountain Railroad announced its newest event, "A Day Out With Thomas", coming to Kingston from September 5th to 7th, and 12th to the 14th, in partnership with HIT Entertainment, a subsidiary of Mattel. Mr. Fluchere also noted Charlie Brown's Great Pumpkin Express is coming to Kingston on October 18th and the Polar Express on November 21st. With the help of Facebook they have already sold 1300 tickets for the Polar Express which 90% are from outside of Ulster County.
- 2. <u>Mike Diablo Wendel</u>: Mr. Wendel spoke to the Ulster County Flood Funds, The Greater Catskill Remediation Bill of \$3,800,000.00 to Ulster County for home buyouts. He expressed that because Ulster County missed the HTFC deadline, they lost \$2 million dollars of state funding to the Orange County Wallkill River Project. Thus, the last forty UC residents applying for relief received grossly inferior appraisals that could not satisfy their existing mortgages, thus residents refused to sell at 70% of market value. Mr. Wendel feels the law has been bent, twisted and broken, and feels there is an ongoing cover up.
- 3. <u>Christopher Closi</u>: Mr. Closi spoke to unsafe conditions at the Hummel Board Home, located at 208 New Salem Rd., Port Ewen. Mr. Closi provided photos and a detailed list of repairs needed at the home. Mr. Closi expressed he is a military veteran and unemployed. Mr. Closi provided the clerk with his resume showing his past work experience and qualifications as a compliance officer and safety inspector.
